Dear Medicaid Provider:

The Department of Medical Assistance Services will be conducting seminars on **Early Intervention (EI) and Child Health Services**. The goal of the training is to enhance the awareness of the scope of Maternal and Child Health (MCH) Services. We will define program and eligibility criteria, enrollment and service access from a variety of public health programs providing Maternal and Child Health Treatment. We will also be including updates on the MCH program services changes that have occurred since our Fall 2005 training.

The seminar is recommended for staff from Health Department Clinics and Child Development Clinics, Department of Social Services, Generic Services Employees, Hospital Case Managers and all Medicaid Case Managers for children. All personnel responsible for administration, services, utilization review, eligibility verification, billing and claims follow-up should be in attendance.

Directions

FAIRFAX-Fairfax County Government Center – Board Auditorium

From I-66, exit onto Fairfax County Parkway North (**Route 7100, Exit #55B**). Turn right onto Fair Lakes Parkway East. Turn right onto Monument Drive. Turn right onto Government Center Parkway. The Government Center is on the left.

RICHMOND- Chippenham Hospital – Kraus Auditorium. (Enter through Tucker Pavilion and take a right to Kraus Auditorium.)

From the north: I-95 south to I-195 West. Merge onto the **Downtown Expressway** (toll). Exit onto **Powhite Parkway** towards VA-150/VA-288/US-60. Proceed on **Powhite Parkway** (toll) to the **Jahnke Road East** Exit. Bear right at the fork in ramp. Hospital will be on your right about ¼ mile. **From the south: I-95 north to Chippenham Parkway North.** Exit at **Jahnke Rd**, and turn right. Hospital is on the right. **Park in the Visitor and Employee Parking Area**

ABINGDON- Southwestern VA Higher Education Center– Auditorium

Hwy. 81 to Exit 14 to Route 140 North (Jonesboro Road). Make a right turn onto VHCC Way (at the stop light). This turn will lead to college campus. On the right, there is a map showing the campus buildings. Continue driving until you reach the bottom of the hill. Meeting will be held in the auditorium.

BEDFORD- Bedford Center for Business- Community Meeting Room

FROM ROANOKE: Take US Route 460 East. Take the third Bedford exit (US-221N/VA) and turn left at the end of the exit ramp onto East Main Street. Take a right (.1 mile) at the first traffic light (CVS Drug) onto Independence Blvd. Travel 1.6 miles and take a right onto Venture Blvd. (Bedford Center for Business stone wall). The College is on the left. Park in the lot with the flag pole.

FROM LYNCHBURG: Take **US Route 460 West.** Take the first Bedford exit just beyond Wendy's). At the end of the exit ramp turn right and take an immediate right (CVS Drug) onto Independence Blvd. Travel 1.6 miles and take a right on Venture Blvd. (Bedford Center for Business stone wall). The College is on the left. Park in the lot with the flag pole.

Newport News- Newport News Health Department, Peninsula Health Center Auditorium

From I-64, take J. Clyde Morris Blvd. **South** exit. Make a left at the light for Riverside Hospital. The Peninsula Health Care Auditorium is to the right of Riverside Hospital. There will be signs identifying the Health Department. Please park in the Health Department parking lots in the front of the building and on the side.
